### RATE-CONTRACT QUOTATION NOTICE

Sealed quotations are invited from experienced and reputed vendors for entering into a district-wise Rate Contract for the supply, installation, and commissioning of CCTV equipment at various Matsyafed offices and commercial units across Kerala. The quotations should be submitted by hand/post to the Managing Director, Matsyafed, Kamaleswaram, Manacaud P.O., Trivandrum - 695009, on or before 26.12.2025 at 3.00 pm. The quotations will be opened at 3.30 pm on the same day. Quotations received after the prescribed date and time will not be considered.

#### **Terms and Conditions**

- 1. The rate-contract will be valid for 12 months from the date of award. It may be further extended up to 6 months on mutual agreement.
- 2. Vendors may quote for one or more districts. The district(s) for which the quotation is submitted must be clearly indicated in the quotation. The vendor must preferably have a: (i) registered office in the quoted district or in its neighbouring district and 2 year or more consecutive experience with Central/State/PSU organizations
  OR
  - (ii) registered office in Kerala and 5 year or more consecutive experience with Central/State/PSU organizations.
  - District details are included in Annexure-1. Experience details with copy of relevant documents must be furnished along with the quotation.
- 3. Prices must be inclusive of all applicable taxes, installation charges, transportation, and other charges. Unit rates must be quoted clearly for each item specified in Annexure-2. No hidden charges will be accepted.
- 4. For each installation, the vendor must visit the site and submit a proposal detailing the required CCTV equipments (including any additional requirements that becomes beyond the rate-contract). Only after obtaining approval from the Matsyafed IT Division should the vendor commence supply and installation. No additional payment will be made beyond the approved amount.
- 5. CCTV system installation must be planned efficiently to minimize cable usage. Placement of OFC cables, Outdoor WiFi CPE Units, network cables, media converters, power supplies, PoE switches, and PoE injectors must be optimized accordingly. Additional cable must be planned in OFC cable laying for repairing on cable break.

- 6. Any additional equipment/device or charges required must be quoted clearly indicating the reason/purpose as specified in Annexure-3. No hidden charges will be accepted.
- Equipment must strictly conform to the technical specifications and warranty in Annexure-2. Brand name and model of each product must be specified. Only BIScertified and standard-compliant products will be accepted. IP Cameras must be STQC certified.
- 8. Vendor may provide additional rates for equipment or charges that may seem to fulfill the purpose in a way of cost efficient, optimized and successful implementation.
- Supply and installation must be completed within 7 working days from the issuance of work order or confirmation of site readiness. Final commissioning will be certified by an authorized official of Matsyafed.
- 10. Site-level configuration, testing, and demonstration of the device/CCTV system is required. Furthermore, basic operational training for site staff is mandatory.
- 11. Payment will be made upon successful supply, installation, testing, and commissioning of the system at each site. No advance payment will be made on the same and part payment for incomplete installations will not be accepted.
- 12. Vendor must ensure timely support in case of software, hardware and installation-related issues during the warranty period of supplied devices even after the contact period.
- 13. Matsyafed reserves the right to inspect supplied materials prior to or post-installation. Any deviation from specifications or substandard supply will lead to rejection and must be replaced at vendor's cost.
- 14. Failure to complete installation within the stipulated time without valid reason will lead to termination of contract.
- 15. Vendor should submit copy of GST registration or PAN details of the organization along with company profile, Proof of registered office in the quoted district or neighboring district, OEM authorization letter/certificate and details of past work experience in similar projects.
- 16. Any violation or non-compliance with the terms and conditions specified above may result in the immediate termination of the contract. In addition, the vendor may be blacklisted from participating in future tenders/contracts with Matsyafed, without any further notice or compensation. Matsyafed reserves the right to take legal or administrative action as deemed necessary.
- 17. Matsyafed reserves the right to accept or reject any or all quotations without assigning any reason.
- 18. Matsyafed reserves the right to award district-wise contracts to different vendors based on compliance and pricing.
